Vincent Square Residents' Association AGM 29 April 2010

CHAIRMAN'S REPORT

Activity during 2009 prepared for the bicentenary of Vincent Square in 2010. An "action group" of residents met in July, September and November; I am extremely grateful to all concerned for their efforts to organise:

- Commemorative Wall Plaque. A plaque has been commissioned from Karen Newman after a competition during the Autumn of seven designs, three of which were shortlisted. The plaque will be erected at the start of November on the corner of 56 Vincent Square, subject to final agreement with the freeholders and planning consent. An unveiling ceremony will be organised. Thanks to Anthony Smith for leading on this project, to the WCC Ward Budget contribution of £6,000 towards the cost of the plaque and to the many residents who have donated; however, more funds are needed.
- Cricket Match. A cricket match fixture "Residents v. Westminster School" is being organised for the afternoon of Sunday, 27 June, followed by the Summer Party in the pavilion. Thanks to Steven Zielenski and Jonathan Katz.
- Westminster Abbey Tour. A Dean Vincent-themed tour, followed by a reception on the evening of 9 November. Thanks to Philip Welsh for organising.

WCC responded to requests to mark the anniversary. They planted trees in Elverton, Rutherford and Hatherley Streets and put benches in Hatherley Street and in front of the College. Unfinished business is a historical notice in Hatherley Street, an engraving on the benches and turning Osbert Street into a play street.

A successful Summer Party was held in the pavilion on a damp July evening by kind permission of Westminster School. The tombola raised £407 for The Passage, one of the two local homeless charities supported by VSRA members. Many thanks to those who donated prizes for the raffle and to the team from Grange Rochester Hotel for the excellent food and drinks.

Tennis benefitted from more hours of access offered by Westminster School, compared to previous years. A request from a company on the Square for corporate tennis membership was declined but the question whether to change the rules is before the AGM. I am grateful to Mary Maxwell, our Tennis Secretary, for organising the Tennis Section.

We end 2009 in a strong financial situation. Tennis costs have risen because of the extra hours and these were not fully covered by tennis fees, with the result that VSRA's accumulated funds diminished slightly. To reflect this, tennis fees for the 2010 season have been raised to £120. In order to proceed with commissioning, the Executive Committee decided to commit £3,000 from accumulated funds for the commemorative wall plaque. I am grateful to Cedric Fan for managing the financial side of the VSRA.
